4	Minutes of last Meeting	Proposed: Pieter Van Der Werf Seconded: Danuta Steedman	
5	Police Update	<p>Majority of reported incidents were road traffic related. 18 incidents including 4 traffic reports/speeding, 1 drunk driver and 1 case of vandalism all dealt with. Not much crime in the area, which is very positive.</p> <p>CR on behalf of the CGCC expressed sympathy for the recent incidents in Bute, and thanks the Police force for their fantastic work.</p> <p>Speeding on the road into Colintraive heading to/from the Ferry is concerning to and considered dangerous by local residents. DC highlights bumps or rumble strips may be a good solution – GB raises the possible use of paint, as an illusion for rumble strips. CG proposes a flashing light highlighting the speed of visitors. GB agrees and states the best way forward for this may be partnership funding with the Council and/or Windfarm.</p> <p>Ferry slipway works in Colintraive are still a work in progress – not known if speed restriction signs will be put up when complete. CGCC advised to contact CMAL to ask to work alongside the Council to make the area safe for Colintraive residents and visitors and curb speeding.</p> <p>Issue with buses raised by CR after witnessing two buses stopping side by side to get on the Bute ferry thereby blocking the road for other users. Road traffic management system promised to be in place by CMAL but not working.</p>	<p>GB to provide quote of cost of Flashing light</p> <p>GB to arrange a site meeting with the Road Traffic Management Team.</p>

6	Development Trust Update	<p>Cowal Way: Work continues. Have approx 6-8 months of present funding remaining and the team are working very hard to get the current project completed within the time limit.</p> <p>Struggling to source core funding, but hope to find a way of employing a local for administrative support, ideally within the next month or so.</p> <p>Stronafian Forest: there is no capacity at present.</p> <p>Clachan Hub: Amber has spent a lot of time working on the Clachan Hub and will report at the next CGDT meeting on 30th of Aug 2018.</p> <p>CG highlights it is a shame that the paths are overgrown and previous maintenance work in the forest has gone to waste. CDS agrees, and says it is due to lack of capacity for the upkeep.</p> <p>DC comments the last minutes on the CGDT website are December 2017.</p>	CDS to update the minutes on the CGDT Website.
7	KCB Update	<p>John Shiveral, Graeme Curran, Fiona MacPhail and Charles Dixon-Spain have put many hours into this project over the past two years and we are now within a week or 2 of knowing whether KCB can go forward with the bidder, or whether the decision has to be made to proceed with R100. Battling to get a compliant bid against the bureaucracy as well as the time scales.</p> <p>The KCB Board's mission is to get 100% coverage and this would probably not be available through R100.</p> <p>If KCB makes any profit, it will be reinvested into the network. CG states that BT have said they may put fiber broadband into Stronafian.</p> <p>CR thanks KCB for the huge amount of work they have undertaken thus far.</p>

8	Councilor's Report	<p>Exam results have gone up throughout the authority, which is very positive. Parking Charges have come into force in Arrochar and soon also in Dunoon. The charge is £1 an hour. The roads have already started to be marked for no parking. Parking attendants will be recruited by the Local Authority. GB confirms the Council did a review on the traffic plans, but decided to implement parking fees. CR states this is very damaging to Dunoon. The same charges in Oban are horrendous and do not encourage people to go/use ferries etc.</p> <p>New plan for four buses to be parked outside the Queen's Hall in Dunoon despite GB raising the point that the buses should be parked at the bus station, but Administration said no. HSCP: £2million coming out of the Council budget, creating a big difficulty for the Council. Residents in Struan Lodge have good quality care. GB raised concerns about one Care Company not paying the travel time of carers and is currently investigating this, as companies must be fairer with workers.</p> <p>ColGlen Roads are struggling with the weather & lorries: many potholes and drainage issues. B roads require sweeping: injuries such as broken hips are happening all too easily across rural areas of Cowal (and A&B as a whole) due to roads and pavements not being maintained. There will be a review by the Council once resources become available. GB will chase the road sweeper for the ColGlen area.</p>	<p>GB to chase road sweeper to maintain the Colintraive/Glendaruel roads.</p>
9	Health & Social Care Update	<p>Struan Lodge redevelopment group are unsure what the future of the group is. The decision has been made to keep it functioning but the plans for expansion and redevelopment, adopted by the group, have not been accepted as yet.</p>

10	Planning	CR wrote to planning ref the Auchnagarron timber road which is going to create a dangerous road situation on the A886. The document written after the Ardtaraig Windfarm meeting held by CGCC will be emailed to planning.	CR to forward document to planning department
11	Scotland Resilient Communities Fund	No response with regard to the grant for the electric car as outcome expected sometime in September. CR contacted Rev. David Mitchell regarding a car charging unit being installed at Kilmodan Parish Church, and he was happy to comply. Unit would tie into the church's electricity system, and they would receive a small amount of money from the charging unit when used. Second unit proposed to be situated at the Colintraive Village Hall, tying into the Hall's electricity supply. If the grant for the car is not successful, we should still go ahead with the charging units. Cost is approx. £1K per charger. Anticipate applying to the Windfarm to cover the costs. Interloch is a Social Enterprise based in Blairmore and they don't have the capacity to give our community what is required in terms of everyday transport, which the electric community car will. In time, CGCC would like to look into having an electric/hybrid mini-bus for community use.
